Johns Hopkins Activity & Mobility Promotion

(JH-AMP) firmly establishes the concept that a systematic approach is beneficial in combating the harms of immobility in our hospitals. While evidence supports the benefits of mobility, implementation has been challenged by clinical “silos” and competing hospital priorities. Implementing interventions requires creating a new collaborative culture and aligning clinical priorities.

This conference features presentations by members of the inter-professional team who have developed this new collaborative culture, successfully integrating mobility as an essential component of hospital operations, quality improvement and safety efforts



Who Should Attend?

This activity is intended for physicians, nurses, occupational therapists, physiatrists, physical therapists, physician assistants, case managers, geriatricians, psychologists, administrators, hospitalists, surgeons and safety-quality professionals.

Objectives

After attending this activity, the learner will demonstrate the ability to:

- Appraise the evidence supporting mobility in the hospital.
- Describe mobility within the context of safe-patient handling and other hospital safety initiatives.
- Explain the tenets and methods of a structured quality improvement process for developing and implementing a system mobility program in the acute hospital setting.

- Describe how to create a clinical culture that recognizes the importance of data.
- Develop clinical questions that can be answered using mobility data.
- Integrate mobility data into ongoing quality improvement efforts.
- Identify stakeholder barriers to implementing an activity and mobility project.
- Engage staff by increasing knowledge of functional assessment tools.
- Facilitate activity and mobility reporting on all patients.
- Describe opportunities to develop an integrated safe patient mobility model.
- Identify interdisciplinary best practices to facilitate activity and mobility.
