Welcome to your clinical experience at the Johns Hopkins Hospital! In addition to reviewing the information in this document, please ensure you have completed all compliance requirements for your clinical experience via the compliance platform provided by the Clinical Coordinator at your school.

#### **Requirements Overview**

### Requirement

- Confirmation of clinical Placement through School Coordinator. Once confirmed, they will direct you to complete the following:
- Confidentiality form: Sign and date the Confidentiality form (exhibit B) included.
- Clinical Waiver and Release: Sign and date the Clinical waiver and release (exhibit C) form included.
- Proof of Immunity: Please provide records to validate your proof of immunity (inoculation date or titers) for the following:
  - MMR
  - PPD results- negative skin test or negative CXR if skin test positive.
  - Hepatitis B
  - Rubella
  - Varicella
  - TDAP- Vaccination after age 19
  - Annual Influenza
  - Covid 19 (minimum requirement is primary course) and any applicable boosters
- JHED ID and Epic Training: with your JHED ID (You should get a separate email with your JHED ID approximately 3-5 days post completion of Appendix A/request for clinical. Please contact us if you do not have a JHED ID) Please follow the instructions included to complete your Epic training and requirements. Please upload your Certificate of completion. (training only needs to be completed one time, not for each rotation)
- Completion of Training for the Maryland State Universal Onboarding Training for Nursing Students.
  - This training includes BBP/Osha, Patient Privacy amongst other trainings that pre=licensure nursing students are required to review.
- Background Check and 9-Panel drug screen: must be dated from within past 12 months. Please provide this information to Janell Pellicio via email at: <a href="mailto:jpellic4@jhmi.edu">jpellic4@jhmi.edu</a>

# **Expectations for Clinical Students:**

## We Expect:

### - Professionalism-

- High level of communication between clinical instructor, students and unit staff. Please notify
  if leaving unit at any time, for breaks and lunch, and at end of day. Students should not be
  performing any patient care if clinical instructor is off unit.
- o Arriving on-time, or early if unit recommends. Leaving clinical day at designated time.
- Dress Code: School issued scrubs. Please do not wear Navy Scrub pants and top as that is our JHHS Nursing Scrub color.
- Wearing appropriate scrub attire and identification for clinical area. Identifying self as a student while in the clinical setting.
- We encourage a high level of engagement/activity for students and instructors in their patients care and needs. In general, we don't anticipate your clinical group to experience a lot of "downtime".

## - Clinical Knowledge and Safety-

- If Giving medications; all medications must be given under the **Direct supervision** of the clinical instructor or JHHS RN Preceptor. All steps of this administration process are to be validated and observed by the instructor or preceptor. All medications will need to have a cosignature from the instructor or Preceptor within Epic.
- Ensure to document in real time, and to not delay the entries of VS, or assessments as this
  may delay the patients plan of care.
- o If you or your instructor are unsure about an order, policy, procedure or protocol, please do not hesitate to ask the nursing staff.
- Provide care only to the patients in which you have been assigned by your clinical instructor.
   If you have been invited to assist or participate in care of another patient, please be sure your instructor approves this, and that you are properly supervised.
